STANDARD FELONY BOND SCHEDULE

AMENDMENT TO LOCAL RULE 24(II)

WHEREAS the Ashland County Jail is experiencing significant overcrowding;

WHEREAS a large number of the current jail population consist of persons charged with felony offenses who have not posted bond, but are awaiting trial under a presumption of innocence; and

WHEREAS more of the existing space and beds within the jail are necessary to effectively execute the sentences of those already convicted and sentenced for criminal offenses.

NOW THEREFORE, in order to ease the pretrial demand for bed space at the Ashland County Jail, to make additional bed space available for sentence execution, and to generally assist in the Sheriff's effective management of demand for bed space at the Ashland County Jail, the General Division of the Ashland County Common Pleas Court hereby adopts the following bond schedule for utilization when setting bonds for those charged with felony criminal offenses, whether by complaint or indictment on and after April 1, 2016:

FELONY 4	Surety or 10% Bail: \$5,000.00	Surety Only: \$7,500.00
FELONY 5	Surety or 10% Bail: \$3,000.00	Surety or 10% Bail: \$5,000.00
Agg. Murder, Murder or Rape	N/A	Case-by-Case Determination

The Court further reserves the right to deviate from this general schedule when exceptional circumstances deem it appropriate.
